## AMENDMENT TO ONE FAMILY DWELLING, HOUSE TRAILER AND TRAILER CAMP ORDINANCE.

The Village of Bancroft ordains:

Section 1.

The Bancroft Village Counsel has determined that the below listed properties in section 5 hereunder had a mobile home or house trailer on the premises prior to October 10, 1994, the date of adoption of Ordinance #205-94.

Section 2.

The below listed properties in section 5 hereunder shall be exempt from the provisions of said Ordinance #205-94

Section 3.

Any below listed property which is currently exempt shall become subject to said Ordinance #205-94 upon change of ownership of said property. Any person owning such property which shall become subject to said Ordinance by virtue of a change of ownership must remove the house trailer or mobile home on the premises within 30 days of the change of ownership.

Section 4.

Any person may petition the Village Council to have their property included as being exempt from this Ordinance, upon a showing that the house trailer or mobile home situated upon the property meets the following criteria:

- A. The house trailer or mobile home was manufactured after June 1, 1976.
- B. The house trailer or mobile home is insurable.
- C. The house trailer or mobile home complies with current mobile home standards.
- D. The house trailer or mobile home and property upon which it is situated otherwise complies with all other Village Ordinances.
