

VILLAGE OF BANCROFT

ORDINANCE NO. 224-03

AN ORDINANCE TO PROVIDE FOR THE COMPENSATION OF THE PRESIDENT, TREASURER, CLERK AND TRUSTEES.

The Village of Bancroft Ordains:

Section 1. Compensation of the President

That the President shall receive a monthly compensation, for regular meetings attended and also compensation for each special meeting and public hearing attended. This compensation shall be paid quarterly and will come out of the General Fund. The amount of this compensation shall be determined by Resolution of the Village Council, subject to annual review. In the absence of the President, the President Pro-Tem shall receive compensation for each meeting he or she attends and conducts in the absence of the President.

Section 2. Compensation of the Clerk

That the Clerk shall receive a monthly compensation, for regular meetings attended and also compensation for each special meeting and public hearing attended. This compensation shall be paid monthly from the General Fund. The amount of this compensation and allocation shall be determined by Resolution of the Village Council, subject to annual review.

Section 3. Compensation of the Treasurer

That the Treasurer shall receive a monthly compensation, for regular meetings attended and also compensation for each special meeting and public hearing attended. This compensation shall be paid monthly from the General Fund. The amount of this compensation and allocation shall be determined by Resolution of the Village Council, subject to annual review.

Section 4. Trustees

That the Trustees shall receive a monthly compensation for regular meetings attended and also compensation for each special meeting and public hearing attended. This compensation shall be paid quarterly from the General Fund. The amount of this compensation shall be determined by Resolution of the Village Council, subject to annual review.

Section 5. Effective Date

This ordinance shall take effect 45 days after the date of its adoption, unless a petition signed by not less than ten percent of the registered electors of the village is filed with the village clerk or village office within such 45 days.

If a petition is filed within such period of time, this ordinance shall then take effect only upon its approval at the next general village election or special village election held on the question of whether the ordinance shall be approved. Notice of the delayed effect of this ordinance and the right of petition under this section shall be published separately at the same time and in the same manner as the ordinance or a notice of the ordinance is published in a local newspaper of general circulation.

Section 6. Adoption

This ordinance shall be adopted by an affirmative vote of at least two-thirds of the members of the village council.

Section 7. Publication

The village clerk shall certify to the adoption of this ordinance and cause the same to be published as required by law.

ORDINANCES 224-03 and 225-03**

I, Shana Post, being the Clerk of the Village of Bancroft, MI do hereby cause to be published the following synopsis of recently adopted ordinances of the Village of Bancroft, pursuant to M.S.A. 5.1274.

At the regular meeting of the Bancroft Village Council, held on May 14, 2003 the following Village ordinances were adopted:

224-03 Compensation of the President, Treasurer, Clerk and Trustees. They shall receive compensation for regular meetings, special meetings, and public hearings. Amount shall be determined by Resolution of the Village Council, subject to annual review.

225-03 NonPartisan Elections. As authorized by section 3(1) and (2), chapter III of the General Law Village Act of 1895 PA 3, MCL 61.1 et seq. As amended, village elections in the Village of Bancroft shall hereafter be nonpartisan.
