An ordinance to designate an enforcing agency to discharge the responsibility of Village of Bancroft provisions of the State Construction Code Act (Act No. 230 of the Public Acts of 1972, as amended)

The Village of Bancroft Ordains:

Section 1. AGENCY DESIGNATED. Pursuant to the provision of the International Mechanical Code, in accordance with Section 9 of Act 230, P.A. 1972, as amended the Mechanical Code Official of the Village of Bancroft is hereby designated as the enforcing agency to discharge the responsibility for the administration and enforcement of said ACT throughout its corporate limits.

Section 2. REPEALS. All ordinances inconsistent with the provisions of this ordinance are hereby repealed.

Section 3. PUBLICATION. This ordinance shall be effective after legal publication and in accordance with provisions of the Act governing same.
